(2) This revenue includes revenue from the increase in the specific tax of 1 cent per litre of gasoline sold within the territory of the Gaspésie–Îles-de-la-Madeleine administrative region (\$1.4 million in 2019-2020), but excludes that from the 3-cent increase per litre of gasoline sold within the territory of the Autorité régionale de transport métropolitain (ARTM), because the ARTM is not included in the government reporting entity.

(3) The General Fund includes revenue from the specific tax of 3 cents per litre on kerosene fuel (domestic), aviation fuel and fuel oil for locomotives.
